

Virginia Railway Express Shop Tour

Saturday, November 8, 2025

Join the Washington, D.C. Chapter, NRHS for a two and a half hour walking tour of the **Virginia Railway Express (VRE) Lifecycle Overhaul and Upgrade (LOU)** facility that performs maintenance and major upgrades including wheel truing capability. The storage yard, located at the south end of VRE's **Fredericksburg Line**, opened in 1992 with the beginning of commuter train operations to Washington DC. Today, fourteen **commuter trains** originate or terminate at Crossroads on a normal weekday. Participants will see how **routine maintenance, repairs, and overhauls** are made to VRE passenger cars and locomotives and learn about VRE initiatives to **improve the commuter rail experience**. This is a **walking tour** of a railroad facility on hard and gravel surfaces so proper, comfortable close-toed shoes are needed.

Tour participants will meet in the VRE Crossroads Maintenance Facility Parking Lot at **9:45am** and then will be led to the appropriate shop entrance to begin the tour promptly at 10:00am. Directions for **free parking** will be provided to tour participants with their tour confirmation.

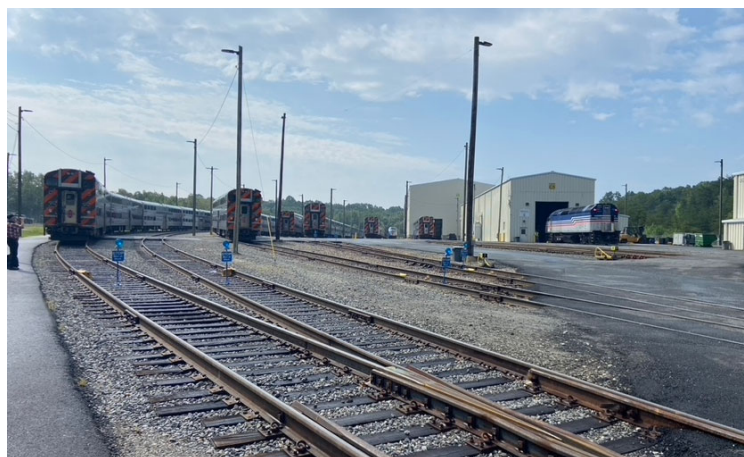

1. No refund or credit after October 17, 2025, other than by operator's cancellation of the trip or reselling of the space. Reservations are not transferable and may not be resold without the consent of the operator.
2. The Washington DC Chapter NRHS makes every effort to accommodate the physically challenged; please discuss your needs with the DCNRHS reservations agent. This tour is of an active Virginia Railway Express facility which is not normally open to the public. Tour participants must be able to stand for times in places without seating, transit over rails, walk over gravel and hard surfaces, and some climbing may be required. Areas of the tour may not be accessible. Operator requires those physically challenged individuals requiring special assistance to be accompanied by someone who is able to assist them.
3. All participants must be dressed appropriately, wearing closed, hard soled shoes (no flip flops, sandals, open shoes, athletic shoes or sneakers or high heels permitted). Participants not properly dressed will be denied entrance, and no refund will be provided.
4. Children above age 12 are welcome on this tour, however each child must be supervised by an accompanying adult. There is no separate child's fare.
5. The General Conditions for tours, trips, excursions and events as published on the DCNRHS web site (www.dcnrhs.org) apply. By making a reservation, participants agree to be bound by both the General and these specific Conditions.
